## Freedom of Information Act 2000

Thank you for your email on 13 July 2019 where you requested information relating to DAERA staff bonuses for the 2018/2019 financial year.

I am writing to advise you that the department has completed its search. I can confirm that we hold the information that you requested and reply as follows:

- Total budget available for staff bonuses for 18/19: DAERA does not allocate any specific budgets for the payment of staff bonuses. In line with Northern Ireland Civil Service Human Resource Policy, the overall cost of Special Bonuses awarded during the course of a financial year must not exceed 0.2% of the pay bill. This figure amounted to £225,933 for 18/19.
